The American Institute of Certified Planners (AICP) Certification Maintenance (CM) program facilitates continuing education activities and events that provide CM credits which are approved by American Planning Association. CLE Most states, including New Jersey and Pennsylvania, require lawyers to take continuing legal education (CLE) courses in order to practice law. As of January 2010, NJ lawyers are required to complete 24 hours of CLE credits over a two-year period. There are ten courses being offered for CLE credits at this year's Atlantic Builders Convention, as approved by the Pennsylvania Continuing Legal Education Board. Approvals are currently pending for the NJ Board on Continuing Legal Education.

US EPA Lead Certification Courses

Beginning April 22, 2010, remodelers and those who perform work for compensation on occupied houses, apartments, schools and daycares built prior to 1978 must comply with the US Environmental Protection Agency's (EPA) new rules regarding lead paint. One of the conditions for compliance is attending a course presented by an approved EPA instructor. Such a course will be presented on April 14 and again on April 15 at the Annual Atlantic Builders Convention. There is a fee for this course in addition to the ABC registration fee, and advanced registration is required. To register, go to <http://abconvention.com/education.php>.
